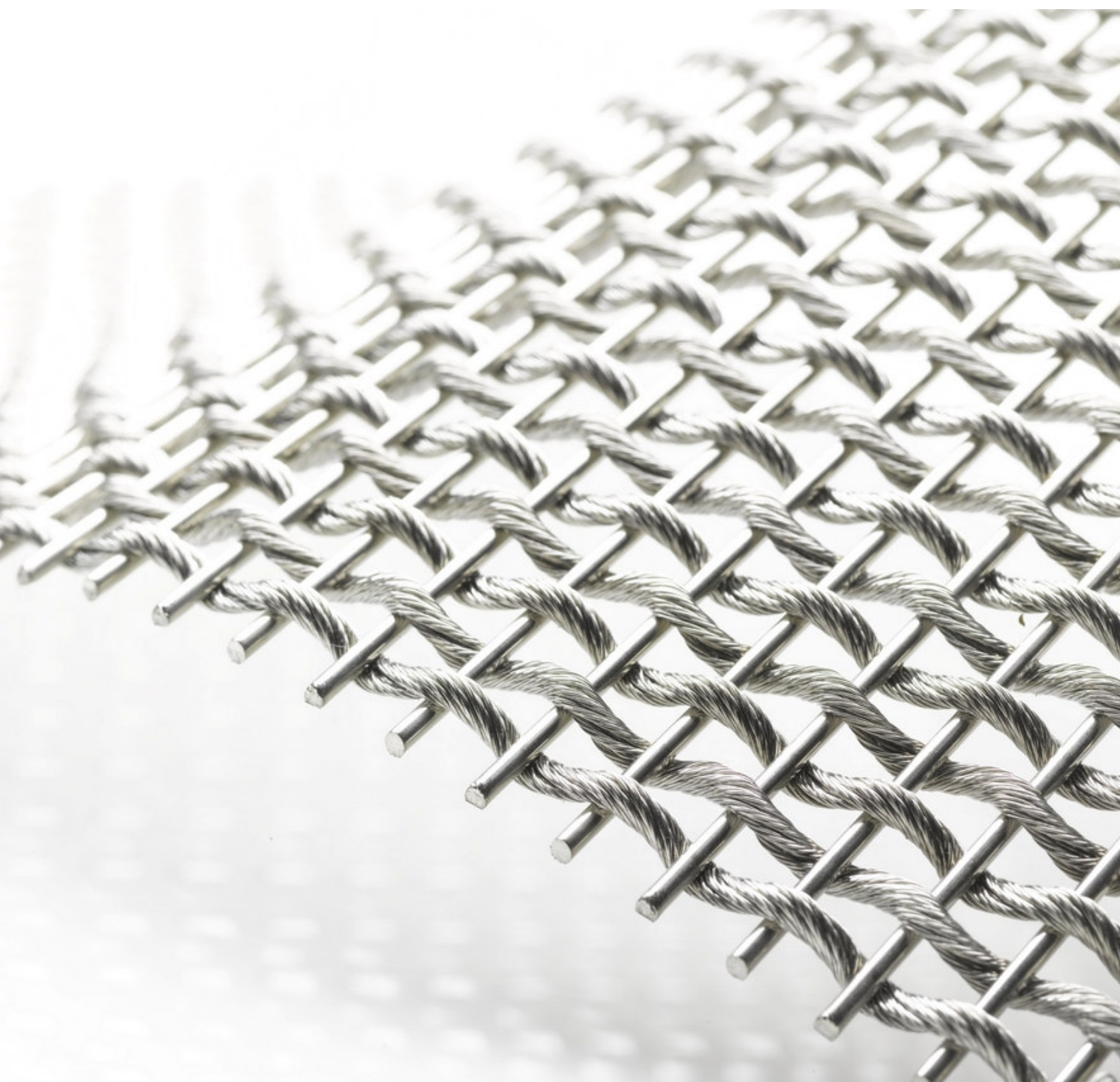

- As far as the application has not been agreed with us, the delivery shall only be made to the usual or advertised specifications. Whether our products are suitable for the intended use is the responsibility of the customer.

However, the market for the materials is considered to be volatile, and price increases and delays could occur.
